The purpose of this consultancy is to review the instruction material and session plans used in the delivery of the H2H parent-child programme and provide recommendations and new or revised instruction material that will improve the service delivery including improving participants' knowledge uptake, ultimately resulting in greater impact for children and parents.

KEY AREAS OF ACCOUNTABILITY:

In an effort to continuously improve our programme and impact for children, we are seeking a consultant to provide the following services:

Positive parenting group for parents:

- 1. Session Plans and Activities
 - Review Positive Parenting Group (PPG) session plans and activities, draft revisions to enhance knowledge retention
 - Develop activities and materials to support parenting skills development
 - Adapt teaching tools for parents of children in different age ranges (under 5, 6 to 9, 10 to 13, 14 to 17)
 - Recommend activities or options for parent's continuous engagement beyond the group sessions

Self-protection group for children:

- 1. Session Plans and Activities
 - Review Children Group (CG) session plans and activities, propose and draft revisions for possible and feasible adjustments to enhance knowledge retention
 - In collaboration and discussion with the core team, create new activities and any materials required
- 2. CG teaching materials
 - Review teaching materials for CG and make recommendations to enhance learning, based on learning development stages
 - Adapt teaching tools/material for children in 3 age ranges (5 to 9, 10 to 13, 14 to 17)
 - Suggest learning tools for children's continuous exploration after the session, such as logbook or online materials
- 3. Moral, Civic and National Education (MCNE) curriculum
 - Provide an adaption of the CG instruction material and session plans that aligns with MCNE requirements
 - Review the MCNE and develop the adaptation and implementation plan
 - Analysis of other service providers, provide recommendations on positioning MCNE adaptation to schools for uptake
- 4. Classroom management and quality reinforcement

- Provide workshops and build staff's capacity on classroom management
- Observe staff's facilitation skills during sessions and provide constructive feedback
