KEY AREAS OF ACCOUNTABILITY

Advocacy and Campaigns are central to securing lasting change in children's lives and is a key aspect of Save the Children's Theory of Change: be the voice – build partnerships – innovate – achieve results at scale. The Advocacy Assistant Manager contributes to the direction and coordination of SCHK policy and campaigning work. The role helps shape the strategic direction of our advocacy activities in Hong Kong, including development and implementation of advocacy and campaign strategies that will engage with the public and partners. The role is part of the Advocacy team, which aims to influence change in public perception, legislation and institutional policies and practice, to achieve positive and lasting changes to fulfil children's rights.

1. Manage advocacy and campaign strategies including:

- Help develop advocacy strategies and lead advocacy efforts to achieve key outcomes for children
- Develop advocacy plans with advocacy manager, implement advocacy projects effectively and maintain financial control
- Work with the program team to ensure substantial integration of advocacy and programmes
- Produce policy briefing papers, policy position statements, articles and public communications related to key advocacy issues
- Help liaise with stakeholders and engage community partners to strengthen our advocacy impact
- Work with Save the Children advocacy global leads and advocacy coordination groups to ensure linkages of local, national and global advocacy issues in a

- manner that informs Save the Children advocacy at all levels, and to ensure coherence of messaging
- Work closely with the Marketing & Communications team to advise on media strategy and to make optimal use of local and international media to influence key advocacy targets and public opinion
- In collaboration with the Marketing & Communications team, seek creative and influential routes to profile issues of importance for children

2. Help manage the Save the Children Youth Ambassador Program and school talks

- Support the advocacy manager to run the Youth Ambassador Program and school talks
- Promote the program to schools. Build school relationships and serve as the key contact person for schools
- Liaise partners and stakeholders to support the Youth Ambassador Program
- Help develop and deliver training to Youth Ambassadors
- Develop and provide materials to youth ambassadors on a variety of child rights related topics

3. Undertake research assignments and support research activities:

- Support quantitative and qualitative research on social issues; analyse, evaluate and interpret data and information collected; draft recommendations based on research findings
- Prepare and disseminate research findings, including writing reports delivering
 presentations on research analyses, both orally and in writing, to peers,
 management, stakeholders, government; and answering questions on research
 design, findings and recommendation

- A good honours degree, preferably in social sciences, politics, journalism, government and law or similar emphasis
- At least 5 years relevant working experience, including experience in a range of campaign, research and advocacy techniques and approaches
- Experience in influencing government, and other organisations through representation and/or advocacy
- Experience managing people
- Strong sensitivity to public affairs and policy
- Possession of a higher research degree in public policy and/or with supervisory experience will be an advantage
- Excellent command of written and spoken Chinese and English
- Familiarity with the operation of the HK legislative council
- Familiarity with child rights topics preferred

- Willingness to engage with different types of individuals and community groups
- Ability to work independently and with a team
- Strong analytical, interpersonal and communication skills
- Ability to work well under pressure
- Self-motivated
