SCOPE OF ROLE

Save the Children Hong Kong's Child Safeguarding Partnerships Service helps child-facing organisations in Hong Kong to ensure that the children they engage with are safe. We work with NGOs, schools and education centres, activity and sports centres, and other child-serving organisations to explore and integrate best practice child-safety standards to their operations and the local context. Through Training Programs, Policy Development Services, Webinars, and Community Information Sessions, we support organisations to strengthen their internal systems and their staff's capacity to prevent and respond to concerns about children's safety.

Child Safeguarding refers to the responsibility of an organisation and its staff to ensure that they do no harm to children. This includes the use of different measures, standards, and protocols to ensure that children are protected from any risks of, or actual, harm that may be caused by the organisation's representatives, programs, or processes.

As Save the Children Hong Kong expands our Child Safeguarding Services across Hong Kong, we are looking for a Cantonese-speaking facilitator to join our team on a full-time basis.

- Manage and maintain client relationships, exploring opportunities to offer continued support clients' Child Safeguarding goals can be recognised and realised.
- Support organisations, in-person and online, to develop action plans for sustainable success.
- Ensure a timely and effective Service experience for all participants, in-person and online.

Support enhancement and quality development of Child Safeguarding Services:

- Maintaining records of Service materials, Services delivered, and participant attendance, whether in-person or online.
- Gather feedback from participants on the quality and impact of Services.
- Collaborate with other Facilitators to run forums, share best practice, leverage experience, and provide ad-hoc support to participating organisations, in-person and online.
- Support design and development of promotional materials for Services.
- Review English Cantonese translations of Service materials, including but not limited to: presentation decks, handouts, activity materials, evaluation forms and surveys, templates, and promotional materials.

- Familiarity with NGO, educational, and/or sports networks in Hong Kong is an advantage
